ADA

WCAG 2.1

The Web Content Accessibility Guidelines (WCAG), created by the World Wide Web Consortium (W3C) set out the industry standards for ensuring that web content is open and accessible for all users. Givzey is WCAG 2.1 AA compliant. We scan our code base using WAVE scans and follow up with human usability testing.

Accessibility Compliance in Other Regions

As a global company with customers and users in over 50 countries worldwide, we similarly follow other local standards such as the European Accessibility Act (EU), Accessibility Canada Act (Canada) and the Equality Act of the UK.

Accessible Functionality

To make our products accessible to all, we support alternative methods of navigation such as screen readers, our interfaces are fully configurable including alternative color

and display choices for the visually impaired.

A2P 10DLC

A2P 10DLC refers to a system in the United States that allows businesses to send **Application-to-Person (A2P)** type messaging via **standard 10-digit long code (10DLC)** phone numbers. All major US carriers require A2P 10DLC number registration. Any SMS or MMS message sent via Givzey is sent through an approved application-to-person (A2P) campaign.
